1. Introduction

2. User Account

Access to the Service requires login via a unique user account. Users must protect their login credentials and must not disclose them to third parties. Each user is responsible for all activity conducted through their account.

3. Community Features

The Service may include features enabling user interaction (e.g., content sharing, etc.). Users agree not to submit any false, unlawful, offensive, hateful, or otherwise inappropriate content through the Service. The Operator reserves the right to moderate, hide, or delete such content.

4. Intellectual Property

All content of the Service, including code, databases, texts, graphics, trademarks, and other elements, is protected by copyright and other intellectual property rights. Copying, distributing, modifying, or otherwise using the content without the Operator’s consent is prohibited.

5. API Access

The Service may provide access to public or partner APIs. Use of the API is permitted only upon separate approval or registration and is subject to specific technical and legal terms. Circumventing, abusing, or overloading the API is prohibited.

6. Prohibition of Automated Data Collection and Use

It is strictly prohibited to:
